#### Trustee's Report

Memorial Field – Deed has been signed and recorded to transfer the property to the Town of Richland. All utilities have been notified of the change of ownership and all accounts have been closed.

CD Renewals – CD's were renewed on December 10<sup>th</sup>. The Township CD remained at \$100,000. The Fire Territory Fund CD was increased from \$35,000 to \$40,000. An additional CD was purchased from the Fire Territory Equipment Replacement Fund for \$10,000. The Township Fund and Fire Territory Fund both have 13 month terms maturing on January 10, 2026 and the Fire Territory Equipment Replacement Fund CD has a term of 5 months maturing on May 10, 2025.

# Rekeying Government Center & Hatfield Station

After discussing the project with fire department personnel, it was decided to proceed with rekeying with security keys instead of an electronic system. One bid has been received from A1 Locks and Felts Lock is to be here to give a quote tomorrow. It was agreed that the 2 quotes would be forwarded to the Board for their comparison and a decision would be made at that time.

Update: On Monday, December 23, the Board agreed through email to proceed with the quote for Keymark high security keys from Felts Lock & Alarm. The email has been made a part of these minutes, starting on page 114.

I've done a little research on the difference between the two keys that are priced by Felts. Both are high security keys. The main difference is that the Medeco can be cut to MANY more configurations for places that need a wider variety of access points. Where we only need 4 different keys that access different doors combinations, USI (for example) might need 26,000 different keys for all the different doors on campus. KeyMark tops out at about 16,000 with Medeco topping out at about 65,000 combinations of key configurations.
