Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objection petition with the proper officers of **Veale Township** not more than seven days after the hearing. The objection petition must identify the provisions of the budget, tax rate, or tax levy to which taxpayers object. If a petition is filed, **Veale Township** shall adopt with the budget a finding concerning the objections in the petition and testimony presented. Following the aforementioned hearing, the proper officers of **Veale Township** will meet to adopt the following budget:


Be it ordained/resolved by the **Veale Township Board** that for the expenses of **VEALE TOWNSHIP, Daviess County** for the year ending December 31, **2026** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition, for the purposes of raising revenue to meet the necessary expenses of **VEALE TOWNSHIP, Daviess County**, the property tax levies and property tax rates as herein specified are included herein. Budget Form 4-B for all funds must be completed and submitted in the manner prescribed by the Department of Local Government Finance.

RESOLUTION OF THE VEALE TOWNSHIP BOARD, DAVIESS COUNTY, INDIANA

WHEREAS, On May 1, 2025, Governor Braun signed into law House Enrolled Act 1461-2025 ("HEA 1461"); and

WHEREAS, Effective July 1, 2025, Section 38 of HEA 1461 adds Ind. Code 36-6-9-12 as a new section, which requires townships to adopt a Capital Improvement Plan ("CIP") on an annual basis; and

WHEREAS, Under Ind. Code 36-6-9-12, all townships are required to adopt a CIP that includes

1. The balance of all unrestricted funds exceeding the township budget for the next year and
2. The purpose for which all unrestricted funds are being retained; and

WHEREAS, Section 35 of HEA 1461 further added the following as the definition of "unrestricted funds" to Ind. Code § 36-6-9-4.5 that identifies "unrestricted funds" as cash reserves that are not:

1. obligated by a township's following year budget
2. committed to a township's capital improvement plan
3. encumbered by a contract or purchase order
4. restricted for a specific use by state or federal law or other applicable state or federal rule;
5. restricted by contractual obligation;
6. restricted by a third party; and

WHEREAS, Section 37 of HEA 1461 amended Ind. Code § 36-6-9-7 to require the adoption of the CIP by September 30 of each year.; and

WHEREAS, Veale Township, Daviess County, Indiana is an Indiana Township that is governed by the laws of the State of Indiana and directed by means of audits and inspections by the Indiana SBOA; and

NOW, THEREFORE, BE IT RESOLVED that the Veale Township Board adopts the **2026 Capital Improvement Plan**.

TOWNSHIP BOARD RESOLUTION




