Respondent appeared in person and was not represented by counsel regarding a Petition to Withdraw Probation scheduled before the Board. The State of Indiana was represented by Britney McMann, Deputy Attorney General and the court reporter sworn in for this

matter was Margie Addington with Accurate Reporting Services.

Jody Edens, Board Director was sworn in as a witness.

Dr. Marcotte informed the Board that she is still with Animal Care Alliance and is doing well. She also indicated that they still have not discovered the cause of her illness and she will be going to Mayo Clinic for testing in a few weeks.

She was placed on indefinite probation due to an opioid addiction. She indicated her sobriety date is September 18, 2018.

Ms. Edens testified that all of Dr. Marcotte's hair follicle and Urine drug tests were all negative. She also indicated that there were letters from IVMA program indicating Dr. Marcotte is compliant with their program and appears every three (3) months. Overall, she is compliant with the terms of her probation order.

The State does not object to Dr. Marcotte coming off probation.

After having considered the evidence presented, testimony of the witness, and taking official, judicial notice of the pleadings, evidence, and orders in this matter the Board moved to WITHDRAW the Order of Probation from Dr. Marcotte's license.

Rebecca McGovern, D.V.M., License No. 24008200A, Cause No. 2020 VB 0014

Respondent appeared in person and was not represented by counsel regarding a Petition to Modify Terms of Probation scheduled before the Board. The State of Indiana was represented by Brittany McMann, Deputy Attorney General and the court reporter sworn in for this matter was Margie Addington with Accurate Reporting Services.

Dr. McGovern is requesting to delete paragraph 9 of her order which indicates as follows: "Respondent shall not have access to controlled substances at her place of employment. After one (1) year from the date of final order, Respondent may request the Board to modify denial of access."

On May 6, 2022 an order granting motion to modify settlement agreement was issued allowing the Respondent access to Pentobarbital, a controlled substance, to euthanize animals at her place of employment.

She indicated that she wants mor controlled substance classes so she can see more patients. She needs them for surgery and critical cases that come in.

Her sobriety date is July 21, 2020, and since November 2021 she has been enrolled in the well-being program. She sees her addictionologist monthly. She attends AA/NA meetings three (3) times per week and sees Ann Kelly every three months and Dr. Farr monthly.

Her controlled substance registration (CSR) is currently expired, and she has previously surrendered her DEA registration. Ms. Edens informed the Board that only the Pharmacy Board has jurisdiction over the controlled substances registration. If the Board allows her to have access to all controlled substances, she will then have to go before the Pharmacy Board to get her CSR back.

The State objects to further access to controlled substances as they would like to see a letter of support from the well-being program and her employer.

After having considered the evidence presented, and taking official, judicial notice of the pleadings, evidence, and orders in this matter the Board moved to DENY the Respondent's request for modification.
