The convictions were based on events that occurred in 2015 and 2022. Dr. McGrath reported that she completed a 16-week drug and alcohol program, attended Mothers Against Drunk Driving meetings, and participated in random urine testing for drugs and alcohol as part of criminal probation, which she successfully completed in 2024. Additionally, Dr. McGrath participates in counseling and has close relationships with family and friends. Further, Dr. McGrath exercises to relieve stress. The board unanimously agreed to grant Dr. McGrath's application for licensure.

The Board issued a letter of reprimand to Respondent.
