III. APPROVAL OF MINUTES (from 7/29 meeting)

IV. REVIEW OF ACTION ITEMS (from 7/29 meeting)

- a. How much is being spent on programs? Discussion:
 - i. James Wilson is preparing some information to share.
 - **ii.** Devon McDonald and Danielle Zagone met with co-chairs of the Diversion Workgroup who will be sharing some information from their work.
 - **iii.** Information provided by DCS was reviewed approximately \$19M spent in SFY 2021 on community-based programs for youth in JD/JS system:
 - 1. Differences in spending among counties noted
 - **2.** Does this account for federal reimbursement?
 - 3. New grant funds should not duplicate services already provided/funded by DCS
 - **4.** Ensure new grant funds are opportunity to fund what is needed, not create programs and counties forced to use what is available
 - 5. Will new grant funds take away from DCS funding? Devon McDonald says should not.
 - **6.** Reminder to access DCS funded services, youth have to have an open case. New grant funds are to support diversion so it's difficult to draw conclusions based on what is currently funded by DCS.
 - **7.** Can we ask in the solicitation about current services and funding sources? Devon McDonald says yes.
 - **8.** The report deadline is January 1 but the solicitation does not need to be done by the same date.
 - **9.** Is the goal to provide funding for services without having system involvement? Yes one of the goals.

b. Data: Filings, Informal Adjustments, Diversion

- i. Devon McDonald shared DOE data on school-based arrests: age could be considered part of the target population.
- ii. Devon McDonald shared IOCS data on referrals and DOC data on admissions.
- iii. Devon McDonald will request additional quarter of data from DCS.
- iv. Devon McDonald will request data from DMHA.
 - 1. DMHA services generally require Medicaid eligibility.
 - 2. County experience is long waitlists for services.
- v. IYI may be additional data source.

d. Funding Formula

- i. Devon McDonald to lead Angie Hensley, Rebecca Humphrey, Leslie Dunn, Danielle Zagone
- ii. Discussion:
 - 1. Potential for regional/multi-county partnerships and impact on total funding for each county as well as categories (travel, etc.)
 - 2. Can providers/non-profits apply or does the applicant have to be a county/governmental agency? Discussion about the need to ensure youth legal system is connected if non-governmental agency is applicant; this can happen through requiring collaborative process and judicial signatory. Expectation of collaboration in JDAI/DOC grant application process.
 - **3.** Can funds be front-loaded (at least partially)? Devon will investigate. There is precedent for this JDAI/JCC grants provide 25% up front and monthly disbursements thereafter. Reimbursement process is cumbersome, particularly with requiring counties or agencies to front the funds. Some may not be able to do so.
 - **4.** Can funds be allocated on calendar year? Challenge ICJI can't obligate funds beyond the end of the fiscal year. Advantage easier for counties most operate on calendar year; prefer two-year cycle with annual budget.
 - **5.** Danielle Zagone with share JDAI/JCC grant funding formula and Leslie Dunn will share the CASA statutory formula.

- **a.** Acknowledge there is a lot of work already being done
- **b.** Devon McDonald advised that he made budget requests of \$10M for Diversion and \$5M for Behavioral Health grants and anticipates needing to add six or seven staff to administer the grants. These amounts were "pulled out of the air", as Devon felt the need to make some request to meet budget deadline.
- c. The Behavioral Health grants will be competitive.
- **d.** James Wilson shared that sustainability is key. His organization developed the Rising Evolution initiative that creates a sustainable ecosystem. James will share additional information in subsequent meeting.
