V. GROUP DISCUSSION

- Update on Youth & Families Meeting
 - o February 4, 2023
 - O The group thought that parental voice is very important and that ongoing education to parents on the justice system is crucial. Parents reported feeling judged and not supported during youth justice involvement. They recommended training to engage parents more.
 - O They want our group to focus on early intervention and identification within the school settings, as well as to provide knowledge and framework to the public as to what our state agencies do.
 - o The group was opposed to having youth "sent out" from their local communities and would prefer a local approach.
 - Peer support in the court was emphasized, having a navigator that could show youth how things work.
 - O Correlations were made to the educational system for youth the group thought it would be best if we could share what agencies are doing to highlight steps in a predictable way and provide recommendations to other groups. The system would be something like the current IEP model.
 - Based on this update, the group highlighted the following items for our overall plan:
 - Peers need to have a network and some kind of training.

- Engagement from agencies to explain the process and how it will affect youth.
- Sharing information between systems (i.e.: IYAS monitoring a child throughout the entirety of their system involvement).
 - Within reason avoiding issues of too much access to records and the potential for having it housed in a way that would negatively impact the youth.
- Clear guidance and education about what the law means compliance focused and tiered system of education for stakeholders, possibly using the state information sharing guide as a starting point.
- Discussion on the workgroup report
 - O This discussion took up the majority of the rest of the time, with workgroup members making revisions and suggestions. A new copy of the draft report will be created, approved by the chairs, and sent out to group members. It will form the basis of our discussion next month.
 - o Deadline of April 7, 2023 to have a draft to YJOC to review.
