# Allen County: Juvenile Diversion Program

## Program Description

The Juvenile Diversion Program is a community-based alternative to formal court proceedings for youth who are assessed as low-risk. This program aims to redirect eligible youth away from the traditional justice system, offering them an opportunity to address their behavior through structured services and support.

Participation in the Diversion Program is based on a mutual agreement between the prosecuting attorney, the youth, and the youth's parent or guardian. To determine eligibility and ensure the program is in the best interest of the youth, the Indiana Youth Assessment System (IYAS) Diversion Tool is utilized as a standardized risk assessment.

Once accepted, a probation officer will meet with the youth and their family to thoroughly review the expectations, requirements, and available services of the Diversion Program. By engaging families and local resources, the program supports accountability, promotes positive behavior change, and reduces the likelihood of future court involvement.

# Dearborn County: Attend and Engage Program

## Program Description

The 7th Judicial Circuit Court - Juvenile Probation and the Dearborn-Ohio County Prosecutor's Office partners with all public schools in Dearborn County as well as Ireland Home Based Services and DCS for the Attend and Engage Program. For grades K-5, Juvenile Probation sends a letter for 6 unexcused absences, 9 unexcused absences, and 12 unexcused absences. The letter for 6 unexcused absences informs the family that if their child continues to accumulate unexcused absences, a referral to Ireland Home Based Services will be made. The letter for 9 unexcused absences informs the family that a referral to Ireland Home Based Services has been made. Juvenile Probation will make that referral to Ireland. If a student were to reach 12 unexcused absences, the letter informs the family of a DCS referral. Juvenile Probation will make that referral as well.

For grades 6-12, Juvenile Probation will mail a letter out for 6 unexcused warning the family that their child could go to court for the charge of Truancy. If a student were to reach 10 unexcused, the SRO would send us a probable cause, and we would do a preliminary inquiry to determine the next steps.

The AEP Program allows us to provide families with services and address one of Dearborn County's biggest issue, truancy.

# Decatur County: WhyTry

## Program Description

The Why Try Program provides simple, hands-on solutions for dropout prevention, violence prevention, truancy reduction, and increased academic success. The idea is straightforward: Teach social and emotional principles to youth in a way they can understand and remember. Why Try is based on sound empirical principles, including solution-focused brief therapy, social and emotional intelligence, and multi-sensory learning. The Why Try curriculum utilizes a series of ten visual analogies that teach important life skills (e.g., decisions have consequences; dealing with peer pressure; obeying laws and rules; plugging into support systems). The visual analogies are reinforced through creative use of music, hands-on activities, and multimedia. Why Try curriculum engages all major learning styles (visual, auditory, and body-kinesthetic).

Referrals are received from school, mental health providers, DCS, CASA, Probation. WhyTry is conducted at school and/or at the Probation Office.

Transportation during the program will be provided by Decatur County Court Services. The skills learned may include financial responsibilities, cooking, cleaning, mechanics, construction, and other service projects.

# Huntington County: Truancy Mediation

## Program Description

We have partnered with our Boys and Girls Club to run our Truancy Mediation Program. We have 6 individuals that are trained through Education for Conflict Resolution (ECR) to conduct our mediations.

When a school has a student with a pattern of absences, the school notifies the parent/guardian. The school also contacts the Mediation Coordinator by emailing her a School Mediation Referral. She contacts the parent to set up the day, time, and place of the mediation (usually sometime during the school day and somewhere at the school). All participants have to be available. Those participants are usually the following: the Assistant Principal, often a school counselor, sometimes a trusted teacher, one or both of the parents (guardians), the student, and two mediators (one mediator to lead the mediation and one to take the notes on the conversation and help draft a final agreement). The actual mediation itself usually does not last longer than an hour, although some exceptionally difficult situations go longer. Mediators initiate and direct a conversation between the parents, the student, and the school officials; and because the mediation is operated as caring but neutral, third-party facilitators, often are able to get information and emotional responses from both the parents and the students that the school personnel have not been able to acquire. Mediators attempt to create a safe atmosphere for both parents and students to take an honest look at their behavior and motivations. Mediators sometimes uncover underlying reasons for the student's absenteeism that require mediators to recommend other county services to them. The mediator facilitates an open and honest conversation but does not dictate any of the terms of the final agreement. The mediator does, however, urge all parties to problem-solve and make concessions, and from that comes a written agreement that all parties sign. Clearly, there is nothing here that is legally binding, but people have agreed face-to-face and signed their name to an agreement. The mediator will then do follow-ups with the family and student for the next few weeks to assess how the agreement decided is going.

If the child completes the diversion agreement successfully, a Petition Alleging Delinquency will not be filed and no further action will be taken. If the child fails to complete the terms of diversion or commits a new offense, the Deputy Prosecuting Attorney will be notified at least fourteen (14) days prior to the end of the diversion agreement and may file a Petition Alleging Delinquency with the court.

The Director of Juvenile Probation will collect all necessary data, complete the annual report and submit it to the Office of Judicial Administration.

# Monroe County: People and Animals Learning Services

## Program Description

People & Animals Learning Services (PALS) is a nonprofit, adaptive riding center located on the west side of Bloomington, IN. PALS provides equine-assisted services to people with disabilities, veterans,

senior citizens, and at-risk youth. Equine therapy offers physical, emotional, and social benefits for a

diverse population. PALS is a Premier-Accredited Center with programming designed to be individualized and safe.

Research supporting animal-assisted activities has been around for decades. A focus on equine assistance

activities, which are interactions between individuals and horses, is a more recent focus, but one with a growing body of evidence supporting the positive impact for youth and families. Wilkie, Germain,

and Theule (2016), through meta-analysis, found equine therapy to be a viable alternative to conventional intervention strategies with at-risk youth, as defined by youth who are experiencing emotional and behavioral difficulties, family discord, maltreatment, and academic difficulties.

The Professional Association of Therapeutic Horsemanship International (PATH Intl.) defines equine assistance

activities as specific activities which include mounted or ground activities, grooming, and stable management, in which clients, participants, volunteers, instructors and equines are involved. Additionally,

PATH Intl. states the goal of equine-assisted activities can develop skills related to improved communication, problem solving or active listening, the bettering of peer relations, processing and managing emotions in general, or even a change of character, in the broad sense of the word.

In a 2022 report, published by Promises Behavioral Health (<https://www.promises.com/addictionblog/>

lessons-equine-therapy), several benefits to equine-assisted activities were noted. Among these:

- Increasing ability to identify, experience, and cope with emotions. Horses have a unique ability to sense emotions and react accordingly. If you are angry or aggressive, the horse may become obstinate.

If you are anxious, the horse may get skittish. But when approached by someone who is open and calm,

the horse is more likely to respond in kind. Witnessing the horse's response promotes self-awareness

and can help people see themselves in a more realistic way.

- Supporting effective communication. Horses do not speak, but they are excellent communicators.

Learning to understand horse behavior can help people learn the way their behavior impacts others.

- Identification of maladaptive thought and behavior patterns. Lessons may be as simple as how much physical space the horse needs to feel comfortable. Without any words at all, horses make clear

when someone has crossed their boundaries. Trying to control or dominate will not work with a horse.

Likewise, a detached or passive approach can make it difficult to lead a horse.

- Acknowledging and overcoming fear. Horses are large animals. Their strength and size can bring up unmet needs, fears, past trauma and feelings of inadequacy or lack of control. Rather than giving in to

their usual reaction — to escape or get defensive — people learn to tolerate and process the emotion. In

a safe environment, clients learn to face their fears. They build confidence in their ability to overcome

challenges.

- Increasing ability to trust. Horses are soothing, gentle animals. They are straightforward in their interactions without lying or manipulating. They do not judge or blame. Their presence alone can be healing.

Through a formalized Memorandum of Understanding (MOU) Monroe County will partner with PALS to

support one (1) 12-week session during the FY 2025 -2026 grant cycle. Details of the MOU specify

## Program Description

Teen Court - The purpose of Teen Court is to reduce recidivism for first time (low risk) juvenile offenders. Teen Court provides the chance for youth to be accountable by providing constructive consequences for their actions, while providing leadership opportunities and resolution training for young volunteers as participants in the peer sentencing court. The program enables the youth to voluntarily take responsibility for their actions, to provide restitution to the victim and/or community, and gives the community a “hands-on” approach in the juvenile justice system.

Participants and family members will be given a scheduled date for their hearing. Hearings will be held on the 1st or 3rd Wednesday of each month at the Porter County Juvenile Services Center. Hearings will last approximately 15 – 20 minutes. During court, a peer jury determines the consequences that are fair and appropriate to each individual case. The jury is made up of youth from the community trained by juvenile services center staff members regarding policy and procedure of the court process. Consequences can include community service, restitution, written apologies, essays, participation in community groups, and other constructive consequences. Juvenile Probation and Detention Officers serve as the defense and prosecuting attorneys, while the Judge is filled by Juvenile Justice Services Department heads.

As a condition of the diversion, youth submit a 2-page typed essay (double spaced, 12 font) which includes the following:

- How does vaping THC differ from smoking it?
- What are some risks of the higher levels of THC found in vaping cartridges?
- Describe how vaping THC and its additives harms your lungs
- Explain how marijuana affects learning, memory, adolescent brain development, and mental health

Essays are to be turned in before the end of the six-month diversion period.

# Porter County: Project ATTEND (Aiming Toward Truancy Elimination and Non-Attendance Decrease)

## Program Description

Project ATTEND - This preventative program is managed by the Porter County Juvenile Probation Department and is designed to address attendance problems without the direct involvement of the Court. Should a child begin to accumulate too many unexcused absences and/or tardies, parents may receive a letter or phone call from the school saying that further attendance issues will result in a referral to Project ATTEND. In Indiana, there is something called the Compulsory School Attendance Law. This law states that children from the age of seven (7) are required to attend school every day, unless legally excused at the age of eighteen (18). If a child begins school before the age of seven (7), the law states a student is bound by this requirement once they are formally enrolled in school.

The law defines absenteeism two ways: Habitual and Chronic. Habitual truancy means a student has been absent ten (10) days or more from school, within a school year, without being excused or without being absent under a parental request that has been filed with the school. In other words, ten (10) unexcused absences within a school year. Chronic absenteeism means the student has been absent from school for ten percent or more of a school year for any reason. In other words, since there are 180 school days a year, the student was absent (excused or unexcused) for eighteen (18) or more days.

If your child falls into either of these two categories, the school has a responsibility to refer the issue to the Juvenile Probation Department's Project ATTEND program as parents are in violation of the Compulsory School Attendance law.

# Ripley County: Attend and Engage Program (AEP)

## Program Description

**Purpose:** The Attend and Engage Program (AEP) is a collaborative effort between South Ripley Schools, Milan Schools, Jac-Cen-Del Schools, Southeastern Indiana Voices for Children, Ireland Home Based Services, Department of Child Services, Juvenile Probation and Ripley Circuit Court. The purpose of AEP is to ensure and enable children to adequately attend elementary school and engage in their education. **Description:** AEP will address elementary school students who have a pattern of accumulating unexcused absences making the student at-risk for educational neglect. The determination of whether a specific absence is excused or unexcused will continue to be made by school officials. After several absences are determined by school officials as unexcused, the school will provide this information to Juvenile Probation. The school will also inform Juvenile Probation to what extent the continued absences have had a negative impact on the student's academic performance. Juvenile Probation will keep the parents informed of the student's cumulative absentee status. If unexcused absences persist, then Juvenile Probation will make referrals to Ireland and/or the DCS. After the referrals are made, and upon a full assessment, DCS will determine what action should be taken. If DCS initiates legal action, Ripley Circuit Court will set these matters for expedited hearings. Furthermore, the Court may appoint a child advocate to represent the child's best interests. **Parameters:** AEP requires that elementary school students accumulate less than twelve (12) unexcused absences in a school year. To ensure this goal is obtained, parents will frequently be informed of their child's attendance status. Parents will be permitted 6 call-ins during the school year which will not count towards unexcused absences. Additionally, community based services will be offered as necessary. **Protocol:** A summary of the day-to-day operative protocol is as follows: A School Staff member will inform Juvenile Probation of elementary students with excessive unexcused absences. This will be accomplished by school officials submitting the Notice of Violation Forms (50% Form, 75% Form, 100% Violation Form) and, if applicable, the Teacher Statement of Educational Impact. These documents shall be filed with Juvenile Probation. A School Staff member will send the parents a letter upon the student accumulating three unexcused absences 25% (3 unexcused). When the student has accumulated (5) unexcused days, the School will hold an attendance conference not more than five instructional days after the student's fifth absence. Juvenile Probation will send the parents a letter upon the student accumulating unexcused absences in the amount of 50% (6 unexcused), 75% (9 unexcused) and 100% (12 unexcused). If there has not previously been a referral to Ireland, then in addition to the 75% letter, Juvenile Probation will make a referral to Ireland. Included in the 100% letter, Juvenile Probation will make a referral to the DCS and include all pertinent documentation. After receiving the referral, the DCS will open an assessment within five (5) days. DCS will determine what action should be taken, including whether to file a CHINS Petition. Ripley Circuit Court will hold hearings on all AEP filings. The Court may appoint a child advocate to represent the student's best interests. The Court will set these matters for expedited processing as follows: at the Initial Hearing a trial will be set within thirty (30) days; upon a child in need of services finding a Dispositional Hearing will be held within fifteen (15) days following the trial; thereafter, Review Hearings will be held at regular intervals starting with two (2) weeks following the Dispositional Hearing. AEP is designed to facilitate educational neglect prevention and, if necessary,

intervention, but will not interfere with or replace the statutory and traditional role of the Court, DCS, Probation and the School Corporation.

# St. Joseph County: Five Star Life - LIFT

## Program Description

LIFT offers families parental support, relationship building, mentoring, conflict resolution, and experiential learning, centered around character, leadership, and mindset curriculum. The program model is implemented as a 6-week cohort, meeting for two to three hours, once a week for six weeks, including a leadership day at Summit. Each session includes a time of connection, a time of collaboration (where youth/families are challenged through team-building activities), a time of learning, reflection, and discussion, and ends with a challenge/action step. Each cohort is set up to focus on specific skills through the curriculum. The curriculum is built upon the research done by Carol Dweck on the power of mindset and the evidence-based practices her work inspired. Some examples of previous cohort focuses include conflict management, restoring your relationships, and ruling over your mental, physical, and emotional health. No matter the focus, the curriculum emphasizes the skills and values we teach to develop and transform your mindset. During the evening session, youth and parents are divided for a time of peer-based discussion to reflect on the topic and discuss their individual takeaways, then families are brought back together to discuss as a group and identify ways the whole family can hold each other accountable to the challenge they have set for themselves. The program model also includes a leadership day at Summit, where families can expand on and explore the personal growth they've experienced during their time in the program. Summit is a place where fears are faced, connections are made, and personal growth is experienced at expedited levels.

Services provided can include, group therapy, family therapy, individual therapy, case management, Healthy Family Services, mental health assessments and are funded through Diversion ICJI Funding.

# Tippecanoe County: School-Justice Partnership

## Program Description

Lafayette School Corporation and Tippecanoe School Corporation have access to divert youth from arrest at the school level for acts our community has come together to determine we are focusing on no longer arresting on school grounds. These include theft (under \$750) if the item is returned, vandalism, push/shove battery with no injury, injury to a school official (if it was a collateral injury while breaking up a fight), disorderly conduct (disruption of education), possession of a knife, fighting without injury, and intimidation without a means to act upon it. Schools Administrators do not involve SROs because no arrest is being pursued and can refer directly into services through Youth Services (that Probation would typically refer) through a form called a Uniform Notice of Offense that is reviewed with parents and students. We have recently added vaping nicotine to the focus acts in order to keep youth in school and offer vape education programming. Youth are referred and participate in services at the school at no cost to the parent or school. Referrals can also be made to our Attendance Intervention Program for ongoing attendance issues through a separate UNO process.

Vanderburgh County Teen Court is a restorative justice-based diversion program that serves first-time juvenile offenders and middle school and high school student volunteers (8th-12th grade). Respondents are sentenced at a hearing of their peers who volunteer to serve as jury members, prosecuting attorneys, defense attorneys, bailiff, and judge's assistant and who are mentored by adult attorneys. Teen Court provides respondents and youth volunteers with the mentors, education, tools, and resources to make positive, healthy choices.

YR's law enforcement and probation partners refer young offenders to Teen Court as a voluntary alternative to the traditional juvenile justice system. Juveniles charged with a low-level offense can forgo the formal hearing and sentencing procedures of juvenile court and participate in a sentencing forum made up of a jury of their peers. Teen Court is not a mock hearing. Youth volunteers take their roles seriously and recognize that it is a privilege and responsibility to participate and to have the opportunity to help a peer.

Teen Court hearings are held on Monday evenings in the Courts Building in the Civic Center Complex.
