

Bias Crimes Electronic Report Submissions

Bias Crimes reports are now able to be submitted electronically. To submit these reports, simply go to <https://pilot.ariesportal.com> and login. Then click the Bias Crimes link on the left side of the screen. If you do not see a Bias Crimes link, your account does not have access to submit Bias Crimes Reports. You may request access by emailing ISPBCR@isp.in.gov.

Once you have access, previously submitted reports will be visible. You may click the Edit link next to the report to edit a previously submitted Bias Crime report. Additionally, any reports that were started and not finished will also be displayed in the Pending Reports section. You may click the Resume button next to the incomplete report to finish it.



Starting a new report

To start a new report, click the “Here” link where the page says “To create a new report, click [HERE](#).”

You must check the box to acknowledge that the type of report is being submitted for bias reporting. Once this is checked, you may click Next to continue.



This report is separate from, and in addition to, the routine Summary UCR submission.

Crimes are to be reported on this form when they have been determined to have actually occurred and are *bias-motivated*, regardless of whether arrests have taken place. Refer to the Data Collection Guidelines from additional information, clarification, and explanation. Detailed federal collection guidelines, applicable to this Report, can be found on the Internet at the ICRC web page and www.fbi.gov/uce.htm


statute details

1. Per IC 10-13-3-38 and 28 USC 534, each law enforcement agency shall collection information concerning bias-related incidents *that are crimes*. At least two times each year, a law enforcement agency shall submit information collected to the Indiana General Repository for criminal history
2. The Incident Report should identify
 - a. the agency
 - b. the agency ORI
 - c. the date of incident (if known)
 - d. the ity of incident
 - e. the county of incident
3. Provide an identifying incident number, which preferable will be your "case" or "file" number.
4. The report should indicate if, in the opinion of the reporting individual and/or data collectors
 - a. bias was the primary motivation for the crime
 - or
 - b. to supplement information in a previously reported crime
5. Indicate the number of offenders, if known, or indicate the number of offenders is unknown.
6. Indicate the suspected offender's race, if known. If there was more than one offender, provide the race of the group as a whole

Report Type

Next you must select your report type. If your goal is to submit a Bias Crime report, then choose Bias Crime as your type of report. Alternatively, if you are wanting to indicate that there were no Bias Crimes to report for a quarter, you may select No Crime Report.


