New Program Integrity provider training – *Modifier 59 and 25 Billing Requirements*

The Indiana Health Coverage Programs (IHCP) will present IHCP Live webinar trainings for Emergency Medical Services (EMS) provider agencies about the new naloxone reimbursement policy.
